



2023 – 2024 SCHOOL PARTICIPATION AGREEMENT

- I certify that my school has timely filed with the Alabama Department of Revenue a "Non-Public School Notice of Intent to Participate" form, and that my school will comply with all the requirements set forth therein.
- I certify that my school is accredited by either the National Council for Private School Accreditation, AdvancEd, the American Association of Christian Schools, or one of their partner accrediting agencies.
- I certify that my school complies with all legal and regulatory requirements associated with the Alabama Accountability Act, including health and safety laws or codes that apply to nonpublic schools, including, but not limited to: (1) immunization record retention; (2) compulsory student attendance requirements as set forth in Section 16-28-7, Code of Alabama 1975; (3) employee and staff criminal background checks under the Alabama Child Protection Act of 1999; (4) nondiscrimination policies as set forth in 42 USC 1981; (5) valid occupancy permit as required by the municipality where the school is located; and (6) fire drill and exit door requirements in Section 36-19-10, Code of Alabama 1975.
- I certify that an approved nationally norm-referenced standardized test will be administered to all RSI scholarship recipients in Grades 2 through 8 and grade 10 and 11, and that their scores will be provided to both the student's parent/guardian and Renaissance Scholarships, Inc. (RSI) and the Alabama Department of Revenue as required by law.
- I certify that my school will provide graduation rates (calculated in a manner consistent with nationally recognized standards) of those students receiving scholarship grants to RSI and the Alabama Department of Revenue or an organization chosen by the State.
- I certify that I understand that I am required to submit proof of the school's financial viability to RSI if scholarship contributions to my school exceed \$50,000 annually.
